By signing this document, I am waiving any and all liability actions which I might pursue against Rockland Precision, LLC for any and all bodily injury or injuries, death or deaths, or property damage, including any and all liability actions arising out of negligence on the part of the Rockland Precision, LLC, its agents, officers, and/or members. _____(Int.)

I acknowledge that I am knowledgeable of firearms and the ammunition I will use while at the Rockland Precision, LLC. I will follow all range and safety rules that have been posted and given verbally while using the Rockland Precision, LLC gun range and during any events that I may participate in. _____(Int.)

I have carefully read this agreement and fully understand its contents. I am aware that this is a release and waiver of liability, assumption of risk and indemnification agreement, and a contract between myself and Rockland Precision, LLC. I understand I have given up substantial rights by signing it and have signed it under my own free will without any inducement and assurance of any nature and intend it to be a complete and unconditional release of all liability

to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect. _____(Int.)
